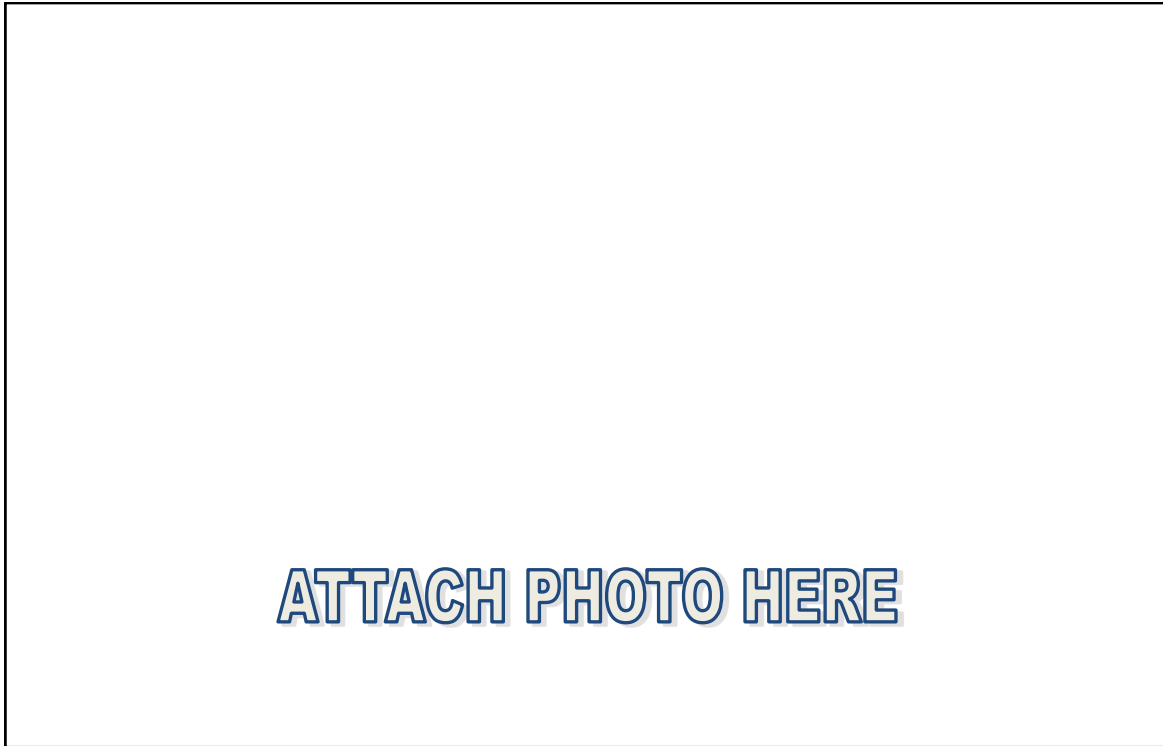
Waiver for Participant and/by Parent

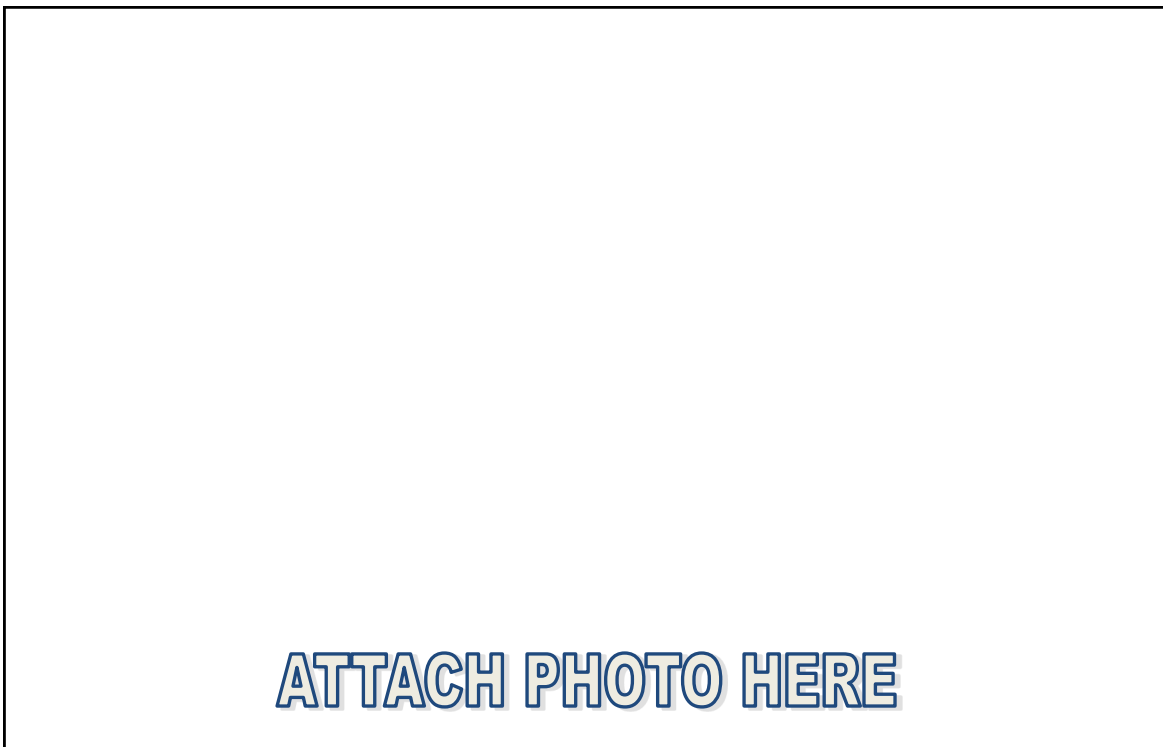

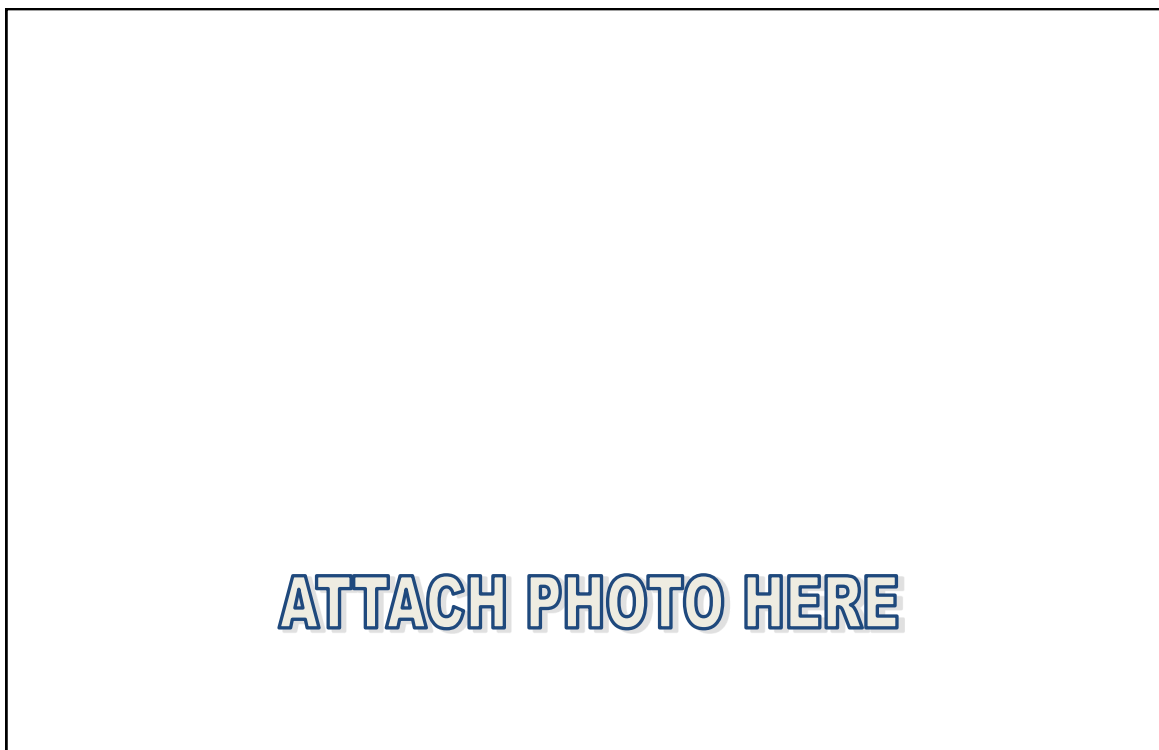

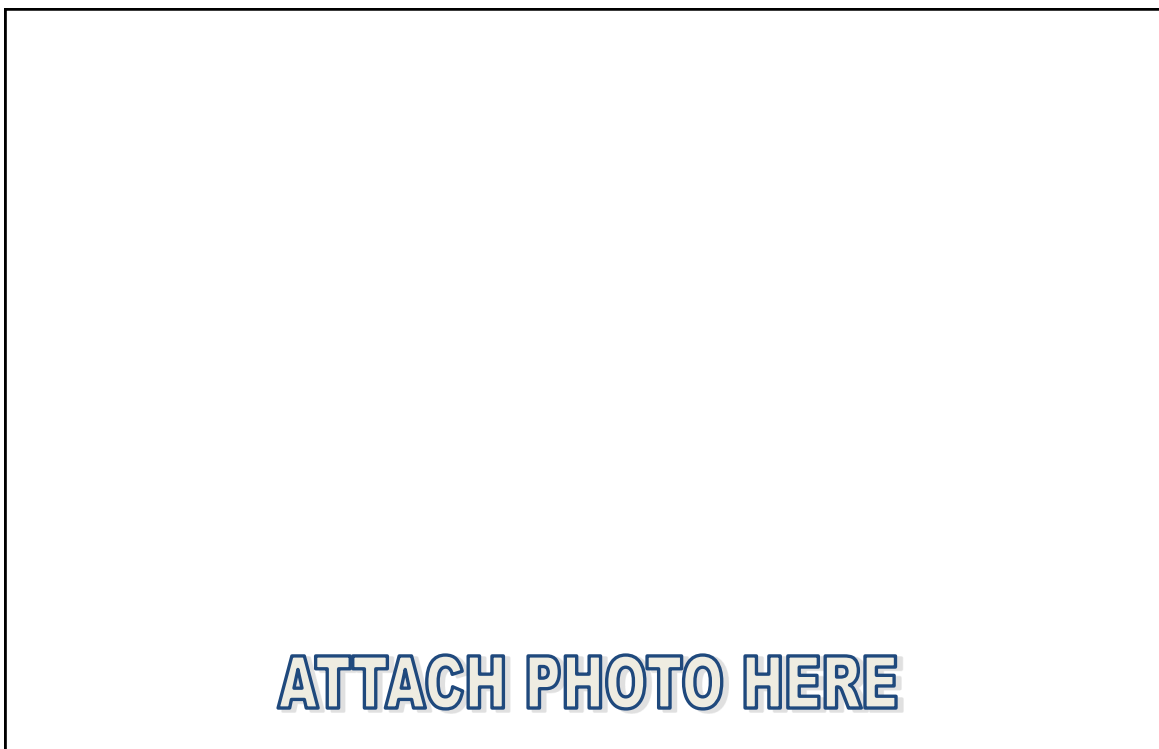

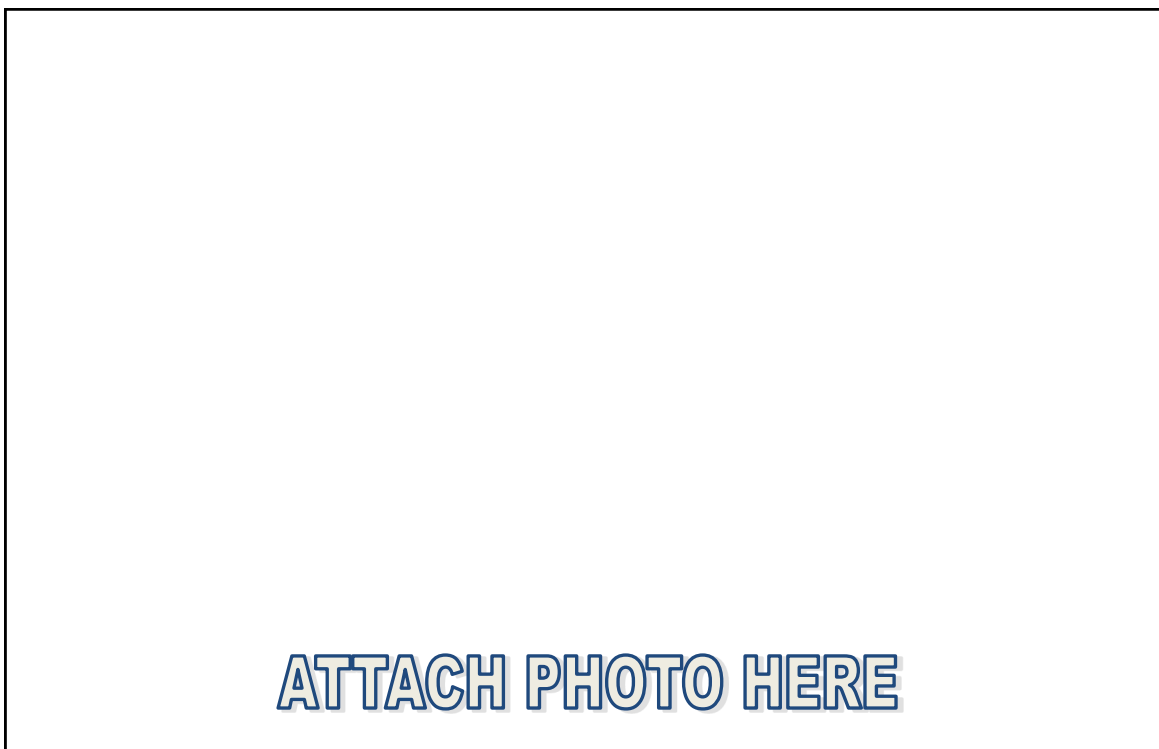

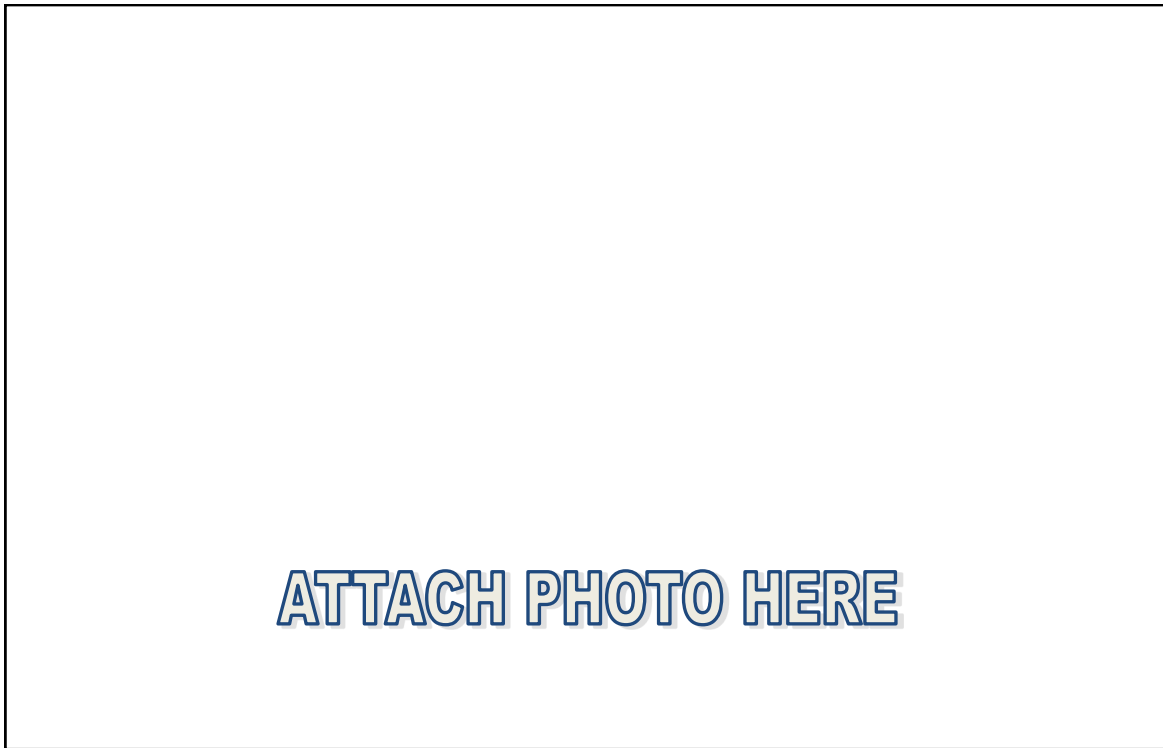

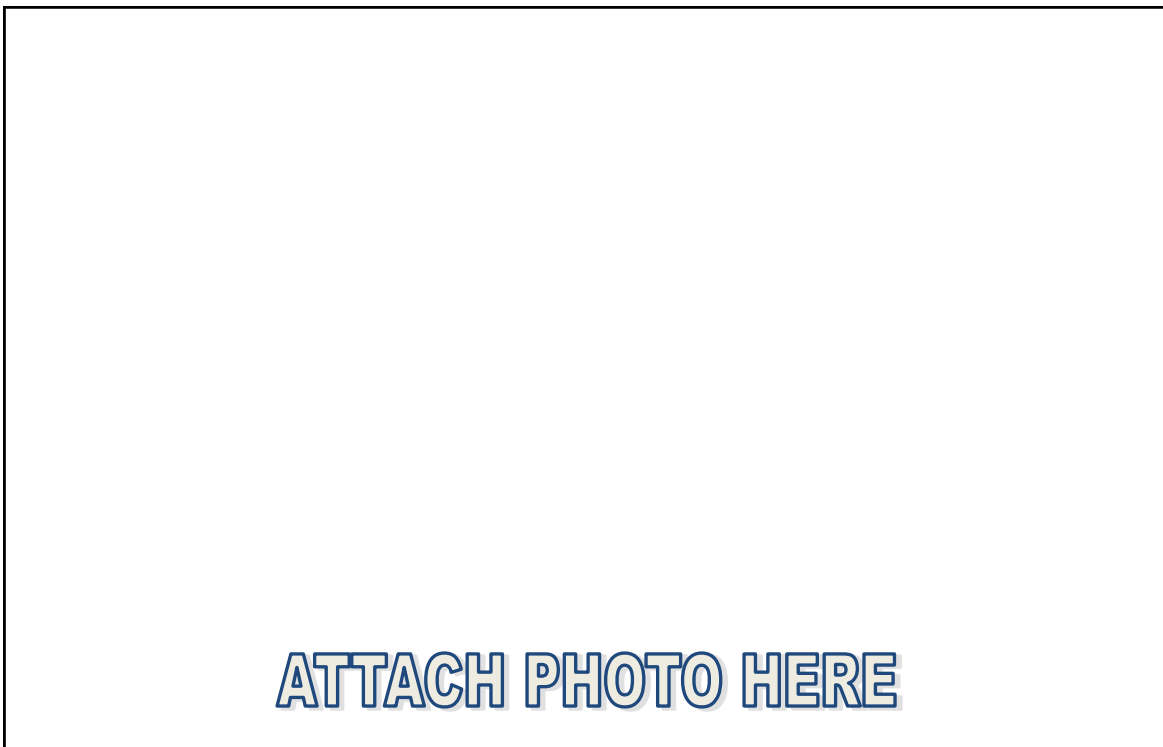
